Weld County Fair Board Meeting

Minutes

July 23, 2023

CALL TO ORDER

The Meeting was called to order at 1:00 p.m. by President Aaron Helus at the Island Grove Park Buckle Club.

Those present were President Helus and Board Members Landon Cogburn, Bailey Naibauer, Levi Loveland, Tom Bledsoe, Courtney Smith, and Isaia Aracayos.

Ex-officio/Staff members present included Extension Director Hannah Swanbom, 4-H Agent Kim Eastwood, and Fair Assistant Cheryl Aragon.

Also present was Committee Member Cody LeBlanc.

GENERAL UPDATES AND DISCUSSION ITEMS

Treasurer Courtney Smith reported that completion of drug testing paperwork was going well, and it was clarified that all drugs must be disclosed on the forms by the exhibitor.

Board Member Tom Bledsoe reported that there may be some discrepancies with the camping map and some problems with spaces in the FS lot.

Board President Aaron Helus reported that he had received a request to consider an appeal to the Jackson Place decision by the Board in July due to him not filing his animal health and housing form by the due date. After discussion, the Board voted unanimously to allow Jackson Place and his family to meet with the Board on July 24th to make his appeal.

July 24, 2023

CALL TO ORDER

The Meeting was called to order at 1:00 p.m. by President Aaron Helus at the Island Grove Park Buckle Club.

He stated that everything else is up to date and that he just overlooked the deadline for the animal care and housing form.

His father noted that when they realized the form was late, they approached his FFA Advisor who guided them to submit it anyway and that it would be sorted out later.

After discussion amongst the Board about Jackson's responsibility in this, the fact that he is showing in breeding not market, and Jackson's owning up to the mistake, the Board voted unanimously to allow Jackson to show, but not allow him to win above the class level.

It was noted that the Superintendent will be notified of this decision.

July 25, 2023

CALL TO ORDER

The Meeting was called to order at 1:00 p.m. by President Aaron Helus at the Island Grove Park Buckle Club.

Committee Member Cody LeBlanc made note that no one knew she was supposed to be helping and that they didn't need the assistance since they've been doing this a long time and know what they are doing and can handle things just fine.

It was clarified by staff that Kat Caswell is the Extension Agronomy Agent who was offering to assist wherever needed, so she was tasked with assisting the Royalty Court in whatever way she could, and that if they didn't need her, she could easily be used in other ways to help with Fair.

President Helus stated that if the Rabbit Show was not set up by 5:00 that day, City staff would be directed to remove all supplies and equipment from that area.

Kim Eastwood reported that 4-H project check in was challenging this year due to the ticket booth and route used to enter the park. She stressed the importance of families having the ability to easily access the 4-H Building to drop off projects on this day.

Discussion ensued about the challenges with the wrist banding and questions about who gets a wrist band and who does not. It was suggested that there be different colors of bands used for exhibitors versus families, for example, and they be marked with Weld County Fair or something that would help to prevent people from buying bands and putting them on themselves. It was noted that this really could work with some good planning and good communication about it.

The Board voted unanimously to direct the Committee to assure that questions are being asked at Vet Checks about Exhibitors and numbers of family members requiring a wrist band to get better control over wrist band issuance.

There being no further business to come before the Board, the meeting adjourned at 1:39 p.m.

July 26, 2023

The Board expressed concern about a vendor who arrived earlier than the vendor check-in time, but not allowed to check in and was left waiting in the Event Center lobby for quite some time.
